

OSU TRANSFER CHECKLIST

As an undocumented or DACA student, know that transferring to Oregon State University is simple. However, we do understand that it can become confusing and overwhelming knowing where to start. The steps in this two-page document are intended to guide you and provide the information you need to successfully transfer.

Getting Started: Plan Ahead

It is important that you start planning at least one and a half years before your intended first term at OSU.


- ❑ **Step 1:** Explore our majors
- ❑ **Step 2:** Determine if this is the right institution for you
- ❑ **Step 3:** Complete the Oregon Student Aid Application (ORSAA)
- ❑ **Step 4:** Learn about the Degree Partnership Program (DPP)
- ❑ **Step 5:** Schedule an appointment with a transfer advisor
- ❑ **Step 6:** Determine which courses will transfer to OSU
- ❑ **Step 7:** Visit campus

Getting Started: Prepare to Apply

To be considered a transfer student, you must have already graduated high school or earned your GED, and have successfully completed a minimum of at least 24 transferable quarter hours (or 16 semester credit hours) from one or more regionally accredited colleges or universities.

- ❑ **Step 8:** Find out if you are eligible to pay in-state tuition
- ❑ **Step 9:** Learn about the transfer admissions process
- ❑ **Step 10:** Become aware of the resources and different financial opportunities available to you
- ❑ **Step 11:** Have a clear understanding of the official transfer policies

Once you have completed the 11 steps on the front side of this document, it is time for you to take action! The steps on this page will guide you through submitting your admissions application and required documents. Please note that this is a guiding document, and it **DOES NOT** replace any interaction with your community college, OSU transfer, or major specific advisors. **It is important that you discuss these steps with both your OSU and community college advisors.**

Taking Action: Apply

OSU accepts transfer admission applications throughout the academic year, however, each term has different admissions deadlines, so be sure to check and submit all of your required documents before the deadline of the term you wish to apply.

- ❑ **Step 12:** If ready to apply, learn more about how to apply as an undocumented student
- ❑ **Step 13:** Are you eligible for Tuition Equity? (Step 8 will help you determine this)
- ❑ **Step 14:** Submit all additional require/supporting documents to the Office of Admission

Taking Action: After You Apply

- ❑ **Step 15:** Check on your application status

Taking Action: Once Admitted

Once you receive your admissions letter to OSU, pay close attention and follow the “Next Steps for Admitted Transfer students”. These steps will guide you in setting up your OSU account along with other relevant information.

- ❑ **Step 16:** Check and follow, the Next Steps for Admitted Transfer Students
